2010 Louisiana Fallen Firefighter Memorial

On March 6, 2010, the Fourth Annual Louisiana Fallen Firefighter Memorial was held on the grounds of the Louisiana State Fire Marshal's office in Baton Rouge. Over five hundred guests and firefighters celebrated the lives of those brave heroes who gave their lives protecting Louisiana's citizens from the dangers of fire. The weather was almost perfect and the whole event was a fitting honorarium to these hero's and their families. The event began with a Horse Drawn Steam Engine leading the Parade of Apparatus which included over thirty fire trucks. This year's main feature was the unveiling of the Memorial's new Eternal Flame. The Flame consists of a 1940's era brass fire nozzle, playpipe and hose. The flame is emitted from the nozzle's tip. The Flame is located at the entrance to the Memorial as a perpetual reminder of the unselfish sacrifice these firefighters made. This tribute would not have been possible without the generous donation of time and money from the Louisiana Gas Association, Atmos Energy, Entergy, Bevelo Gas and Electric Lights, Central Plumbing, Ferrara Fire Apparatus and the city of Berwick Fire Department. Fire Chief Michael L. Kuk was the quest speaker and he spoke of Saint Florian, who is the patron saint of firefighters.
