# Membership Dues

## Gas Transmission Members:

Members engaged in transmission of gas shall pay annual dues based on the annual throughput for the year immediately prior to the association's fiscal year.

## Gas Distribution Members:

Members engaged in the distribution or delivery of gas shall pay annual dues based on the number of meters in the state of Louisiana billed during the month of December immediately prior to the association's fiscal year.
